

Affiliate Membership Subsidy Program at EPTC 2022

To encourage EPS membership and engagement, EPS has initiated an Affiliate Membership Subsidy Program whereby non-member conference registrations at EPTC will be offered a complimentary EPS Affiliate Membership for the following year. After the conference, EPS will contact all non-IEEE member registrants to complete a form if they wish to apply for the complimentary affiliate membership. EPS will cover the cost of the affiliate membership once the application is approved, at a cost of US\$76.50 (EPS will waive its US\$15 membership fee that would normally be included in the \$91.50 total affiliate membership price).
