The 25th IEEE Electronics Packaging Technology Conference (EPTC2023) is an international event organized by the IEEE RS/EP/EDS Singapore Chapter and co-sponsored by the IEEE Electronics Packaging Society (EPS). EPTC2023 conference will feature keynotes, technical sessions, technology talks, virtual exhibition corners and networking activities. It aims to provide a platform to cover the technology developments in the complete spectrum of electronics packaging from design to manufacturing. Since its inauguration in 1997, EPTC has been established as a highly reputable international electronics packaging conference and is the IEEE EPS flagship conference in the Asia and Pacific Region 10, covering diverse areas of electronic packaging technology topics. These include modules, components, materials, equipment technology, assembly, reliability, interconnect design, device and systems packaging, heterogeneous integration, wafer-level packaging, flexible electronics, LED, IoT, 5G, emerging technologies, 2.5D/3D integration technology, smart manufacturing, automation, and AI.

The EPTC Technical Program Committee, with more than 100 experts from diverse semiconductor packaging technology areas, is committed to creating an engaging technical program for the international packaging community. 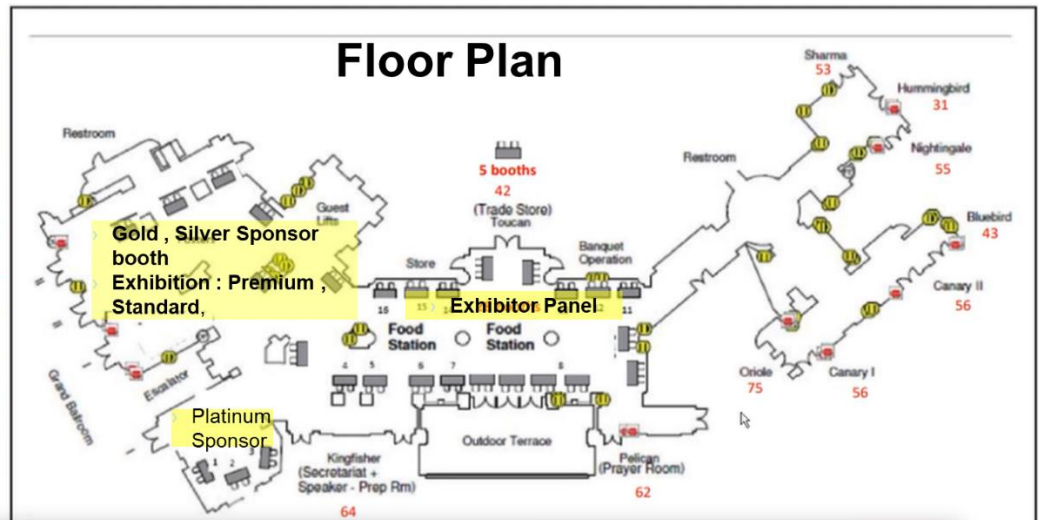
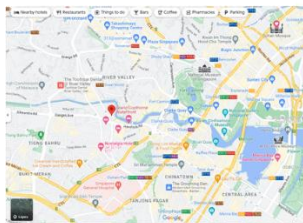

RULES AND REGULATIONS

The rules and regulations printed on here of shall constitute part of this contract and the exhibitor agrees to abide and conform here to. By signing below, the individual whose name appears on this contract represents that He/she is duly authorized to execute this binding contract on behalf of the named exhibitor. This contract shall not be binding unless and until accepted and approved in writing by the EPTC 2023's authorized person

Qualification of Exhibitor: Exhibitor must be a manufacturer or independent representative of a manufacturer which produces products that conform to the subject matter covered in the technical program or that are used in relevant ancillary work (such as trade magazines or books)

Products and Services to be Exhibited: No exhibitor shall exhibit, or permit to be exhibited, in the space allotted to it any goods or services other than those that conform to the subject matter covered in the technical program, nor shall it exhibit, or permit to be exhibited, displays or advertises material of any sort, bearing any name or form of advertisement other than its own.

Space Usage and Allocation: Allotted space to be used solely for the exhibitor whose name appears on the application and it is agreed that the applicant will not assign, sublet or apportion the whole or any part of the allotted space without the prior written approval of EPTC 2023.

Exhibit & Display Rules and Regulations: Exhibitors may place assign/posters/literature on the poster panels provided. Tabletop equipment are allowed but please do check with EPTC 2023 committee for more details.

Contests, Promotions, and Literature Distribution: Sponsors and Exhibitors shall not permit exhibition raffles, donations, or other promotional measures that require guests to be present at a specified location and time.

Prohibited Functions: Any function which is not part of the EPTC 2023 "Official Program" is prohibited.

Liability Release and Indemnification: Sponsors and Exhibitor releases EPTC 2023, its sponsors from any claims, liabilities, losses, damages, costs, or expenses relating to or arising out of any injury, loss or damage to the hotel property or theirs. Sponsors and Exhibitor shall indemnify, defend and hold harmless EPTC 2023, its sponsors from any claims, liabilities, losses, damages, costs, or expenses relating to or arising out of any injury, loss or damage to the hotel property or theirs.

Refund Policy: EPTC 2023 will refund the sponsors and exhibitor as follows in the event of cancellation or withdrawal: a) Cancellation made before 30 September 2023 - S\$800/- net; b) Cancellation made before 31 October 2023 - S\$300/- nett ; c) No refund will be made if cancellation is made after 31 October 2023.

Authority of Exhibition Management: EPTC 2023 shall have the authority to adopt and enforce all rules and regulations with respect to the event adopted by it or set forth herein. EPTC 2023 decision on such matters shall be final
